Vancouver, BC – August 24, 2020 – HighGold Mining Inc. (TSX-V:HIGH) ("HighGold" or the "Company"). On Friday, August 21, 2020, The Globe and Mail, a Canadian national newspaper, issued a news item that included reference to a fraudulent website of nearly the same website address (URL) as the Company. HighGold Mining Inc. is in no way associated with this fake website. The Company's management urges shareholders, stakeholders and other news outlets to please check your information sources or news copy thoroughly to avoid confusion and passing on incorrect information from fake websites.

HighGold is a mineral exploration company focused on high-grade gold projects located in North America. HighGold's flagship asset is the high-grade Johnson Tract Gold (Zn-Cu) Project located in accessible Southcentral Alaska, USA that contains an Indicated Resource of 2.14 Mt grading 10.93 g/t gold equivalent (AuEq) for 750,000 ounces AuEq and an additional Inferred Resource of 0.58 Mt grading 7.16 g/t gold equivalent for 134,000 ounces AuEq (see Technical Report titled "Initial Mineral Resource Estimate for the Johnson Tract Project, Alaska" dated June 15, 2020) along with excellent exploration potential indicated by several other prospects over a 12-kilometer strike length. The Company also controls a portfolio of quality gold projects in the greater Timmins gold camp, Ontario, Canada that includes the Munro-Croesus Gold property, which is renowned for its high-grade mineralization, and the large Golden Mile and Golden Perimeter properties.
