HighGold Mining Responds to Helicopter Incident at Johnson Tract Project, Alaska

Vancouver, BC – August 26, 2020 – HighGold Mining Inc. (TSX-V:HIGH) ("**HighGold**" or the "**Company**") reports that a helicopter incident occurred yesterday at our Johnson Tract Project in Alaska. A helicopter operated by our local contractor sustained significant damage following a forced landing event. No passengers were on board and thankfully the pilot received only minor injuries.

Health, safety, and well-being of the people working at the Johnson Tract Project remains our highest priority. Our on-site team responded immediately and efficiently to secure the well being of the pilot and our other personnel in accordance with HighGold's response plans. The helicopter contractor will be investigating the cause of the incident in cooperation with the Federal Aviation Administration and the National Transportation Safety Board.

The contractor's second helicopter remains on site to service the three drill rigs in operation as well as geophysical and geological survey crews.

"We are grateful that no one was significantly injured, and we will continue to make the health and safety of our employees and contractors a top priority at HighGold Mining," said President & CEO Darwin Green.

HighGold is a mineral exploration company focused on high-grade gold projects located in North America. HighGold's flagship asset is the high-grade Johnson Tract Gold (Zn-Cu) Project located in accessible Southcentral Alaska, USA that contains an Indicated Resource of 2.14 Mt grading 10.93 g/t gold equivalent (AuEq) for 750,000 ounces AuEq and an additional Inferred Resource of 0.58 Mt grading 7.16 g/t gold equivalent for 134,000 ounces AuEq (see Technical Report titled "Initial Mineral Resource Estimate for the Johnson Tract Project, Alaska" dated June 15, 2020) along with excellent exploration potential indicated by several other prospects over a 12-kilometer strike length. The Company also controls a portfolio of quality gold projects in the greater Timmins gold camp, Ontario, Canada that includes the Munro-Croesus Gold property, which is renowned for its high-grade mineralization, and the large Golden Mile and Golden Perimeter properties. HighGold's experienced Board and senior management team, are committed to creating shareholder value through the discovery process, careful allocation of capital, and environmentally/socially responsible mineral exploration.
