The Johnson Tract Project, Alaska

The Johnson Tract Project is a poly-metallic (gold, copper, zinc, silver, lead) project located near tidewater in Southcentral Alaska. The project includes the high-grade Johnson Tract Deposit (JT Deposit) and numerous mineral prospects over a 12-kilometre strike length.

Originally explored from 1982 to 1995, the project was inactive for almost 25 years prior to acquisition by HighGold in 2019. The large land package is under explored with significant exploration potential. HighGold is focused on both expanding the JT Deposit and generating new discoveries.

Prior to becoming the Chief Exploration Geologist for HighGold Mining (focused on exploration at the Johnson Tract project), Dr. Steeves contributed to the exploration success at Constantine Metals' Palmer Project in southeast Alaska as Exploration Manager.

HighGold's flagship asset is the high-grade Johnson Tract Gold (Zn-Cu) Project located in accessible Southcentral Alaska, USA that contains an Indicated Resource of 2.14 Mt grading 10.93 g/t gold equivalent (AuEq) for 750,000 ounces AuEq and an additional Inferred Resource of 0.58 Mt grading 7.16 g/t gold equivalent for 134,000 ounces AuEq (see Technical Report titled "Initial Mineral Resource Estimate for the Johnson Tract Project, Alaska" dated June 15, 2020) along with excellent exploration potential indicated by several other prospects over a 12-kilometer strike length. The Company also controls a portfolio of quality gold projects in the greater Timmins gold camp, Ontario, Canada that includes the Munro-Croesus Gold property, which is renowned for its high-grade mineralization, and the large Golden Mile and Golden Perimeter properties. HighGold's experienced Board and senior management team, are committed to creating shareholder value through the discovery process, careful allocation of capital, and environmentally/socially responsible mineral exploration.
